

OFFICIAL PROGRAM RULES AND REGULATIONS

- One (1) Grand Prize winner will receive a brand new car provided by Nalley Automotive of Brunswick. The Grand Prize
 winner will be responsible for all sales taxes, registration fees, license plate fees, and income taxes including local, state, and federal
 taxes.
- 2. Five (5) finalists will be notified by email and/or phone call on Wednesday, November 20, 2024 that they have been selected as a finalist for the Grand Prize. The finalists will be invited to attend the final announcement, where the Grand Prize winner will be selected from the five (5) finalists.
- 3. Must be 18 years of age or older and a legal resident of the state of Georgia to be eligible for the Grand Prize. The raffle is void where prohibited and restricted by law.
- 4. Employees of the Davis Love Foundation are not eligible to win the Grand Prize.
- 5. Participants will receive one (1) entry into the raffle for each \$20 contributed. There is no limit on the number of entries by any one individual.
- 6. The purchase of a raffle ticket (\$20 per ticket) is non-tax deductible. Individuals have the option of making an in-kind donation through the program, which are considered 100% tax deductible. No goods and/or services in exchange for an in-kind donation will be received. All in-kind donations will qualify for the Bonus Pool funds distributed to participating charities by the Davis Love Foundation.
- 7. All printed tickets must be received by Friday, November 1, 2024 and all online purchases must be made by Friday, November 15, 2024. Any entries received after this time will not qualify for the Grand Prize drawing.
- 8. Clear, legible handwriting is the responsibility of all participants. The Davis Love Foundation shall not be responsible for errors caused by illegible entry forms. Entry forms without a clear charity designation will go to the Davis Love Foundation and will be added to the bonus pool which benefits all participating charities.
- 9. Participants must provide an email and/or phone number in order to be eligible for the Grand Prize. Participants that do not provide this information will not qualify.
- 10. Entries for the raffle will be sold by participating charitable organizations only. Charitable organizations that have been denied or have not registered in the program will not qualify to receive proceeds from raffle ticket sales.
- 11. Raffle tickets will be distributed to participating charities in June 2024. All qualified raffle tickets must be collected by participating charities and submitted to the Davis Love Foundation for eligibility. No exceptions.
- 12. 100% of raffle ticket sales will be given to the charitable organization identified on the entry form. The charity name cannot be changed. The Davis Love Foundation reserves the to right to deny any entry forms that appear to be altered for the benefit of another organization.
- 13. Charities participating in the program must be publicly supported and recognized by the IRS as a 501(c)(3) non-profit organization. The Davis Love Foundation reserves the right to approve or deny any charity from participating in the program, specifically if the participating charity's mission statement does not align with the mission of the Davis Love Foundation—supporting children and families in need.
- 14. All participating charities must be located in the state of Georgia to qualify for participation in the program due to interstate gaming regulations.
- 15. It is the responsibility of the participating charitable organization to provide an entry form for each contribution. The participating charitable organization will be responsible for any discrepancies between the contributions listed on the entry forms and the collected contributions.
- 16. Methods of payment are limited to cash, checks and credit cards only.
